We refer to our appointment of Statutory Auditors of Vashishtha Luxury Fashion Limited for a period of 5 years (FY 2023-24 to FY 2027-28) in Annual General Meeting held on December 31, 2023.

We refer to our discussion for our proposed fees and our estimated effort to carry out the audit of the financial statements for the year ended March 31, 2026. However, the Company has requested us to reduce the fees for the statutory audit of the financial statements for the year ended March 31, 2026.
