The order, issued under Section 154 of the Income Tax Act, 1961, levies a demand of Rs 1.81 Lakhs, along with a detailed break-up of the assessment. This rectification order has been passed in response to the rectification application filed by the Company following the receipt of an intimation under Section 143(1) of the Income Tax Act, 1961. In view of the discrepancies addressed in the rectification order, the Company has filed an appeal under Section 246A of the Income Tax Act, 1961 before the Income Tax Appellate Tribunal challenging the said order. The appeal is currently pending further hearing and the passing of an order by the concerned authorities.
